पत्रावली पेश हुई। प्रार्थी प्रतिनिधि उपस्थित। प्रार्थी की बहस सुनी गई। प्रकरण के संक्षिप्त तथ्य इस प्रकार हैं कि प्रार्थी श्री भीमसिंह, चेयरमैन के0बी0एस0 एजुकेशन ट्रस्ट, जयपुर ने प्रार्थना पत्र प्रपत्र-8 अन्तर्गत धारा 23 राजस्थान सार्वजनिक प्रन्यास अधिनियम 1959 के तहत दिनांक 5.11.2011 को प्रस्तुत कर निवेदन किया कि न्यास के पूर्व प्रन्यासी श्री अशोक सिरौही एवं श्री पांचूराम द्वारा प्रन्यासी पद से त्यागपत्र दिये जाने व त्याग पत्र स्वीकार कर उनके स्थान पर श्री अभिनव सिंह एवं अभिषेक सिंह को नया न्यासी नियुक्त किया गया है। अतः उक्त परिवर्तन के सम्बन्ध में प्रन्यास रजिस्टर की प्रविष्टियों में आवश्यक संशोधन दर्ज किये जावे। प्रार्थी द्वारा प्रस्तुत प्रार्थना पत्र दर्ज रजिस्टर किया गया।

प्रार्थना पत्र के समर्थन में श्री अशोक सिरौही (अधिकार पत्र धारक) ने अपनी साक्ष्य दर्ज कराई। प्रार्थना पत्र के समर्थन में प्रार्थी की ओर से श्री अशोक सिरौही के अधिकार पत्र की प्रति प्रदर्श-1, प्रपत्र-8 में सूचना प्रदर्श-2, पूर्व न्यासी श्री अशोक सिरौही एवं पांचूराम के त्याग पत्रों की प्रति प्रदर्श-3 व 4, उक्त न्यासियों त्याग पत्र स्वीकृति हेतु पारित प्रस्तावों की प्रतियां प्रदर्श-5 व 6, नये न्यासियों की नियुक्ति हेतु पारित प्रस्ताव की प्रति प्रदर्श-7 व 8, नवनियुक्त न्यासी श्री अभिषेक सिंह व श्री अभिनव सिंह के सहमति पत्र की प्रतियां प्रदर्श-9 व 10 प्रस्तुत किये गये।

प्रार्थी द्वारा प्रस्तुत प्रार्थना पत्र के सम्बन्ध में प्रस्तुत साक्ष्य एवं दस्तावेजों का अवलोकन किया गया तथा बहस पर मनन किया गया। प्रन्यास द्वारा किये गये परिवर्तन न्यास विधान में दिये गये प्रावधान अनुसार है जो न्यासहित में है। अतः प्रन्यास अधिनियम की धारा 23 में प्रदत्त शक्तियों का उपयोग करते हुवे प्रार्थी द्वारा प्रस्तुत प्रार्थना पत्र (प्रपत्र-8) दिनांक 05.11.2011 स्वीकार किया जातू है। तदनुसार प्रपत्र-4 में इन्द्राज किया जावे। इस प्रन्यास के वर्तमान में निम्न न्यासी हैं:-

TRUST DEED

This deed of trust is made at JAIPUR on this 2nd of February, 2006, Thursday, between Shri Bhim Singh S/o. Sh. Padam Singh, age about 48 years, R/o. A-32, Nityanand Nagar, Queens Road, Jaipur aged 50 years, of one part, AND

3. Smt. Sneha Lata D/o. Shri Albel Singh, age about 42 years, R/o. A-32, Nityanand Nagar, Jaipur (Raj).

(Hereinafter collectively called the trustees which expression shall wherever the context so admits or requires to be deemed to include the said trustees and the survivor or survivors of their and the respective heirs, executors and administrators of such survivors they are or their assignees and the trustees or trustee for the time being of these presents) of the OTHER PART.

WHEREAS the AUTHOR of the trust has been cherishing a desire to serve the mankind and the fellow needy human beings.

AND WHEREAS, the AUTHOR desirous of establishing a public charitable trust for the objectives set out here below sets a sum of Rs. 11,000/- (Rs. Eleven Thousand) which shall be called trust fund.

AND WHEREAS the trustees have also accepted the trust fund, as stated above.

NOW, therefore, this deed of the trust declares and witnesses as under:-

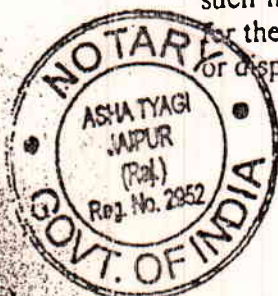
1. The name of the trust shall be "K.B.S. EDUCATION TRUST". The abbreviated name K.B.S. stands for Kunwar Bhim Singh. Hereinafter called the trust.
2. The office of the shall be at A-32, Nityanmand Nagar, queens Road, Jaipur (Rajasthan) and can be shifted to any other place within the state of Rajasthan with mutual consent of the trustees.
3. The trust is created with following objects mentioned below:-
 - i) to impart education in all fields of engineering, commerce, science, arts including law, medical, paramedical and technical, professional, conventional and non-conventional area of education on regular and correspondence basis.
 - ii) To provide training, coaching and research facilities for qualifying competitive exams in the various field either held in India or outside India
 - iii) To acquire, hold, lease hold or free hold land and undertake construction of building or buildings or take building or buildings on rent in order to achieve the objects of the society.
 - iv) To start various education programs in school, college and education centers and apply for necessary permissions / affiliations with various university state govt., central govt. and national / international authority or any other authority for the time being in force where its necessary permissions/ sanctions required for running the education program as stated above.

- v) To establish and maintain school, college, hostel, library, archives, reading room, placement bureau, museums, exhibition halls, conference rooms, theatres, canteens and research centre etc.
- vi) To publish journals, periodicals, bulletins and other publications in furtherance of the aims and the objects of the trust.
- vii) To co-operate and affiliate with any other trust, society, institution, organization, having similar objects.
- viii) To hold and manage endowments and to establish awards, fellowship, scholarship, stipends, medals and prizes.
- ix) To raise funds and to receive donations grant in aid and to accept loans etc from governmental and non governmental agencies or from any other sources in order to achieve the aims and object of the trust.
- x) To create and promote reliable efficient information and data bank for better preparation or professional technical and civil services examination.
- xi) To arrange/ undertake short, intermediate and long term research workshop studio circles and tours in the main aim of the working of the trust.
- xii) To create and promote pool of experts/ professional to adequately meet the growing demand for consultancy services fro the enterprises level onward to national and international level on the issue, science, commerce and arts.
- xiii) To initiate level; proceeding or defend and take all necessary actions for the protection of the legitimate rights, interests and work of the trust
- xiv) Establish and award research fellowship and to finance specific research projects.
- xv) To construct build establish acquire assist maintain manage administer run purchase get hospital nursing homes, medical, dental, nursing colleges, clinic, dispensary field welfare centre, health centre, health farms and farm houses, hotels etc.
- xvi) To purchase, take on lease, accept as a gift or otherwise acquire any land or building which may be necessary or convenient for the trust.
- xvii) To proceed the trust to be registered or recognized any parts of India or any other foreign country or places.
- xviii) To pay all expenses primary or incidental to the formation of the trust and its registration.
- xix) For the propose of the trust to draw accept, make, endorse, discount and negotiate govt. of India and other promissory notes, bill of exchange cheque other negotiable instruments.
- xx) To borrow and raise money with or without security or on the security of a mortgage, charge, or on the security of hypothecation or pledge of all or any of the movable or immovable property belonging to the trust or any other manner whatsoever.
- xxi) To invite to the funds or money entrusted to the trust upon such security or in such manner as may from time to time determined by the Board of Trustees for the purpose of income tax examination from time to time to sell, transpose or dispose of such investment.

- xxii) To work for nation building through education
- xxiii) To undertake any work related to academy field.
- xxiv) To sell assign mortgage lease license exchange or otherwise transfer or dispose off all or any property movable or immovable of the trust.
- xxv) To appoint or employ temporary or permanently any person and to pay them or other deputed or seconded person for services rendered to the society such as salaries, wages, gratuity, p.f. pension and introduce and implement welfare schemes including but not limited to superannuation housing scheme, for the benefit of such person as the trust may on its behalf determined.
- xxvi) To do all such other lawful things as the trust may consider necessary expedient incidental or conducive to the attainment of the above objects.
- xxvii) Provided that the trust shall not support with its funds endeavor to impose on or procure to be observed by its trustees or otherwise any regulation or restriction which would make the trust a trade union.

4. All mankind indiscriminate on the basis of caste, colour, creed, religion, sex or language shall be the beneficiaries of this trust.
5. i) The initial fund of the trust is Rs. 11,000/- (Rs. Eleven Thousand) contributed by the AUTHOR and shall be used for the objects of the trust. More funds can be generated by receiving contributions, grants and donations from Author, trustees and the general public or other donor agency together with income accruing on the property held by the trust from time to time.
ii) That it is agreed that no part of the trust fund shall be utilised for the benefit of the AUTHOR of the trust or any of the trustee.
6. The funds of the trust shall not be applied for any purposes other than the objects of the trust stated in Para 3 above.
7. That the management and control of affairs of the trust shall be vested in the BOARD of Trustees which will consist of trustees, its chairman, its secretary and a treasurer.
8. The BOARD of Trustees shall have the power to acquire immovable property or movable properties of the trust and likewise the power to sell, lease or mortgage or otherwise deal with such properties with written consent of chairman and the secretary.
9. The administration of the trust hereby constituted and the entire control, regulation, management and application of the trust fund shall be in the uncontrolled discretion of the trustees, chairman and secretary,

10. the trustees may at any time invite and receive or without such invitation any voluntary contributions from any person or persons whomsoever either by way of donation or annual or other subscription or legacy or otherwise for the support or for the benefit of the trust hereby constituted and declared but with written consent of chairman and secretary.
11. the trustees may at any time make such arrangements, draw up such schemes and frame such by-laws and rules as they shall in their discretion think fit for the administration of the trust hereby constituted.
12. Every power, authority or discretion herein or hereinafter conferred upon the trustees shall be exercised or signified either by some instrument in writing to be signed by all the trustees or by the resolution of a majority of the trustees who shall be present and vote at the meeting of the trustees provided that notice of intention to hold such meeting and the business to be transacted thereat shall have been given to all the trustees and provide that no less than three of the trustees shall attend and vote upon the question to be decided by the resolution. The chairman of the meeting shall have a second or casting vote in case of an equality of votes for and against any resolution.
13. A general meeting of the trustees shall be held at least once in every year at which accounts of the trust hereby constituted and a report concerning the same to be prepared by such person or persons and in such manner as the trustees direct, shall be presented.
14. the trustees are hereby authorised to appoint a general secretary and to pay him out of trust fund a salary as the trustees think fit provided that if the any trustee appointed as secretary, he shall not be entitled to be paid any salary. It shall be the duty of the secretary to summon meeting of the trustees and enter minutes of all the proceedings at such meetings in a book.
15. provided always that the AUTHOR of the trust shall during his life so long as he shall remain a trustee of this deed be and have the privilege of the chairman of any such meeting as aforesaid at which he shall be present and it shall not be competent for the trustees by any rules or regulations passed by them or otherwise to deprive him of this right and he is having a right to declare its legal heir and successors.
16. proper accounts showing all receipts and disbursements made on account of the trust hereby constituted shall be kept by the trustees and shall be duly audited with all necessary vouchers at least once in every year by such auditors as the trustees shall appoint. Such auditor must be a qualified accountant within the meaning of the Chartered Accountants Act, 1949.

17. The total number of trustees shall not be more than five and shall not be less than three. If at any time either before or after a vacancy shall occur in the number of trustees hereby appointed, the trustees shall consider it expedient to appoint an additional trustee or trustees of the deed with written consent of chairman and secretary. It shall be lawful for them to appoint any person or persons whom they may select to be additional trustee or trustees and on every such appointment, the trust property be transferred to or vested in the trustees or trustee for the time being but shall not be necessary or incumbent on the trustees or trustee for the time being to procure the trust property or so much or such part thereof as aforesaid to be so transferred to or vested in them or him until the number of trustees qualified as competent to act under this deed shall have been reduced to three but every trustee so appointed may as well before as after the trust property or so transferred or vested execute all the trust powers and discretions of this deed and in all respect act in the same manner as if he had been hereby constituted as trustee.
18. every person who shall be appointed as new or an additional trustee of this deed must be a citizen of India.
19. the trustees may delegate all or any of powers, authorities and discretions, hereinbefore conferred on them except those conferred by clause (10), (11), (13) and (14) of this deed to any committees. Such a committee may consist either of the trustees or of some of the trustees together with any other person or persons or of any other persons not being trustees whom the trustee may select provided that the trustees may at any time revoke either wholly or partly the authority so conferred on any such committee.
20. in case of the non-observance of the terms of the trust at any time by the trustees for any reason whatsoever, and if there shall remain any property or funds whatsoever belonging to trust, the same shall be given to any other public society or trust or any other association having similar objects as is of the trust hereby constituted be determined by the AUTHOR so long as he is alive and thereafter his successors along with other trustees.
21. first secretary of the trust will be smt. Snehlata (trustee and party of second part)
22. Abhishek singh s/o. sh. Bhim singh and abhinav singh s/o. sh. Bhim singh will be the legal heir and successors of the Author of the trust.
23. The trust can accept or give others contributions and donations for the object mentioned above.
24. In creating or disposing any immovable or movable property, taking or giving loans, written consent of the chairman of the trust must be needed.
